The buyer must take the dog to a licensed veterinarian within 48 hours of time of transfer.

Any implied health warranty is void if the Buyer does not make the required vet visit within the 48 hour time period.

In the event that your veterinarian finds that the puppy has a life threatening untreatable illness a refund (or replacement pup of the same quality within a reasonable time limit) will be given, providing a letter from the examining veterinarian is produced specifically stating that the puppy has a life threatening illness and is not expected to survive, and the puppy is returned to the seller within the guarantee period.

(NOTE: Parvo is covered for 10 days from date of pickup.) Hypoglycemia is not covered, due to being the responsibility of the buyer to make sure the puppy eats.

The seller warrants the dog against life threatening congenital defects for a period of one year. The seller warrants that to the best of their knowledge this puppy is in good healthy condition. The seller will replace the puppy if it dies due to any congenital defect provided the following conditions are met.

1. Buyer must consult with seller within 24 hrs. Of any illness and follow the advice of the seller's veterinarian.
2. Buyer must have an autopsy preformed by sellers Veterinarian of choice within 24 hours of death.
3. Seller is not responsible for any medical expenses after purchase.

The buyer understands that the seller has limited information or control regarding the puppy's size as an adult and can only be estimated based on the size of both parents, but there is no specific guarantee.

Deposit Policy: Deposit of 50% of total cost of pup is due at time of reservation for litter or upcoming litter. Deposit is nonrefundable except in the case of illness, death, or obvious health problem with puppy and puppy is not eligible for adoption at time of pickup, or in the case of future litters, if sex, size, and color are not available. Deposits can be held for the next litter or refunded in the above mentioned cases only. For any other reason, the deposit is nonrefundable but will be reviewed on a case per case basis.

We accept Cash, Money Order, Credit Card, or Paypal for deposits and final payments. Credit Card and Paypal payments will incur an additional 3.5% service fee for payment.
